The FIRST PARTY has agreed for the proposal of the SECOND PARTY for a period of **03 year (from 09/12/2020 to 08/12/2022)** on the terms and conditions below:-

- 1. The institute will working under the name and flagship of **X Computer Institute**.
- 2. The Second Party has no authority to make any agreement with new authorized training center in his region also the Second Party has no right to use the name of First Party in any agreement with any person /company / institution / society / organization & if it made then the First party have no connection / liability or any responsibility regarding that agreement which made by the Second Party.

- That The Second Part is authorized as Franchise for the Purpose of computer Education (SOFTWARE, HARDWARE and NETWORKING) Only.
- 2. That The Second Party is strictly directed to open the centre at such place where the Govt. Authority / MC or Local Public has no Objection.
- 3. Excellence provides I-Card, Fee Card to each student at the time of admission.
- 4. Excellence conduct the Semesters and Final Examination of the course.
- 5. The all required items will be issued by the respective Corporate Office/RO Office.
- 6. The Students will be awarded ISO Certified Certificates on the basis of marks obtained by them.
